The Vocational Nursing (VN) Program is a full time, **12 month** curriculum which offers both theory and practical hands-on training necessary to become a Licensed Vocational Nurse. The program is Monday Through Thursday, some Fridays, and Saturdays are required. The times vary from 6:30 in the morning to 5:30 in the afternoon.

The program will cover medical/surgical, gynecology, obstetrics, pediatrics, pharmacology, psychology, geriatric nursing, rehabilitation, leadership along with other fundamentals.

Every student is expected to meet all course requirements before being eligible for completion and meeting the State's requirements. Upon completion, you will be eligible to take the state examination with the Board of Vocational Nursing (NCLEX-PN).

REQUIREMENTS:

An Official **High School Transcript** or **GED** transcript is **REQUIRED**. If you have foreign High School transcript you must have it evaluated by AACRAO. You can contact AACRAO at <http://www.aacrao.org>

Students must bring their High School Diploma **and** Official School Transcripts, Evaluated Foreign Transcripts done by AACRAO or GED certificate at the time of registration or provide documents before the first Day of class.

Take the VN orientation; take a TABE test, the top 60 candidates will move on to a PRE-VN course.

VN PROGRAM

During PRE-VN you will need to complete the following:

BACKGROUND/FINGERPRINTING CHECKS - \$78 (EXTRA):

All students will be required to complete a background/fingerprinting check. Only students with cleared results will progress in the program. The cost to the background company is approximately (may be subject to change) \$78.

Background checks will be completed during Pre-VN.

Must pass the PRE-VN program with a 75% overall and a 75% on the final, pass the Background check, candidates who meet the 75% will be paneled interviewed. The top 33 will move on to the VN program.

COURSE OBJECTIVE:

The Vocational Nursing (VN) course prepares the VN student to provide care for patients of all ages with a variety of medical conditions and traumatic injuries. The VN student will be to provide care for people who are physically and mentally ill, the handicapped, frail elderly, and others. Under the supervision of doctors and registered nurses, they do nursing that requires technical knowledge. In the clinical setting, they will take vital signs, client teaching, keep medical charts, change dressing, and assist clients. The VN student will learn how to collect data, assists the health care team to implement and evaluate nursing care for their client's record. They will learn to administer prescribed medications and injections.

JOB OUTLOOK

Employment of Licensed Vocational Nurses (LVNs) is projected to grow 16 percent from 2014 to 2024, much faster than the average for all occupations. As the baby-boom population ages, the overall need for healthcare services is expected to increase. LVNs will be needed in residential care facilities, specialty clinics, rehabilitation facilities, schools and in home health environments to care for older patients.

Growth in the middle-aged and elderly population will lead to an increase in the number of age-related health problems, such as heart attacks or strokes. This, in turn, will create greater demand for LVNs. A number of chronic conditions, such as diabetes and obesity, have become more prevalent in recent years. LVNs will be needed to assist and care for patients with chronic conditions in skilled nursing and other extended care facilities. In addition, many procedures that once could be done only in hospitals are now being done outside of hospitals, creating demand in other settings, such as outpatient care centers.

The number of individuals who have access to health insurance is expected to continue to increase because of federal health insurance reform. LVNs will be needed, particularly in ambulatory care settings, to care for the newly insured who seek primary and preventative care services.

CLASSROOM DRESS CODE:

MEDICAL REQUIREMENTS:

MUST BE COMPLETED DURING BY THE END OF THE THIRD WEEK OF FUNDAMENTALS

A current physical within the last 12 months prior to the beginning of the course, signed by a physician that specifies that you have no physical limitations for participating in the classroom and clinical components of the course.

SEE ATTACHED DAS STUDENT HEALTH RECORD – Must be submitted to DAS before student will be allowed to progress in the program.

- Healthcare Provider Evaluation (See above for date requirement)
- **Hepatitis B** positive titers within the last year
- **Measles-Mumps-Rubella (MMR)**, positive titers within the last year
- **Tuberculosis:** A negative TB skin test within three months of the beginning of the course. If you had a positive reaction to a previous skin test, please provide documentation of a negative chest x-ray.
- **Varicella:** positive titers within the last year
- **Proof of COVID-19** Vaccination
- **Flu Vaccination** (During Flu Season)

***If any of the above titers are NEGATIVE student must provide proof of a recent vaccine.**

NOTE: Medical requirements may change based upon Clinical Facility Requirements.
